Note 1 – Of the \$325K outstanding for Planning Debtors:

- \$180K relates to Engineering fees which become payable upon statement of compliance;
- \$57K is being reviewed and followed up by the Planning Department; and
- \$30K relates to Developer fees which are to be written off \$58K relates to a contribution being followed up by Planning.

Note 2 – Enforcement debtors follow court processes that exceed general debt collection timeframes. They are still reported above as being payable within 30 days, however statutory processes can take up to 12 to 18 months.

Note 3 – The initial invoice of \$165K was reversed, subsequent invoices totalling \$118K have now been raised and are likely to be paid by the end of October.

Note 4 – Larger companies using our waste service have been contacted regarding payments terms and streamlining payment of invoices. However, \$58K of the \$67K outstanding has been paid as at 13th October.

Note 5 – A number of improvements to debt collection have been implemented to reduce outstanding Preschool related debt levels. Of the outstanding debt:

- \$30K is relating to the 2017 school year and is now being collected via reminders, SMS reminders and Final Notices accordingly.
- \$28K is at the debt collectors relating to previous school years.
- \$7K is on payment arrangement via direct debit.
- \$7K has been paid in the first 2 weeks of October.
- \$6K is on voluntary payment arrangement.

Note 6 – The process for Fire Hazard debtors is currently being reviewed to establish a clear recovery process moving forward and to assess any outstanding debts.

Note 7 – Building debtors are now being managed through the process of issuing reminder letters and referral to debt collection agencies.

Note 8 - At this stage recovery of the \$22K outstanding debt for CFA Mt Hickey Fires is doubtful.

Note 9 – Grant acquittals for Harley Hammond and Broadford Sports Pavilion have been completed and are awaiting acceptance and payment from the Sports and Recreation Victoria.

Note 10 – Invoices to Seymour Football Netball Club (\$10K) and St Mary's (\$2K) have been followed up by the Recreation and Open Space Team and are likely to be paid by the end of October.

Note 11 – The outstanding amount of \$22K represents \$11K owing by Visy and \$11K owing by Cleanaway for waste education contributions. The Visy amount is considered doubtful, and the Cleanaway debt will be discussed during a scheduled meeting with Cleanaway's new contract manager.

Councillor Allowances and Superannuation

This category covers registration fees associated with attendance by Councillors within Victoria at one-off or short-term training, conferences and/or functions held by local government related organisations, professional bodies or institutions.

Travel and Accommodation

This category covers expenses associated with attendance by Councillors within Victoria at approved short-term training, conferences and/or functions. Council's Councillor Expense and Support Policy provides for the reimbursement of car parking fees, e-tags and use of private vehicle while conducting Council business.

6. Conclusion

Council's most significant financial challenges are moving to a consistent adjusted underlying operational surplus and enabling increased capital works into the future, to fund renewal of existing assets and provide new assets/services for our growing community. Council's 2017/18 Budget and 2018-2021 SRP continue to show steady progress towards improved long term Financial Sustainability.

The adopted budget showed an adjusted underlying deficit of \$4.54M. The current forecast indicates a \$350K improvement on the adopted budget. Staff are continually seeking improvements and efficiencies wherever possible.

Preparation of the 2018/19 budget is now underway with Council's goals and strategies being review.
